The Pony Club is an international youth organisation dedicated to providing opportunities for young people that are interested in horses, ponies and riding. Pony Clubs exist to promote the holistic development of young people by encouraging sportsmanship and good citizenship. Through pony club, opportunities are provided to young riders to gain knowledge and become proficient in their chosen equestrian sport.

The Pony Club movement started in the United Kingdom in 1929 with the stated aim of encouraging young people to learn to ride and enjoy all kinds of sport connected with horses and riding.

The first Pony Club in Western Australia was established in 1959. Pony Club Western Australia (Pony Club WA) is the recognised state sporting organisation representing the interests of 12 zones, 55 clubs and over 3311 members.

Chairperson's Report

This past year has been successful yet challenging one for the team at Pony Club WA, with a busy schedule of events, a change in leadership, and hosting of the 2023 Nationals.

I am pleased to report that we have achieved significant progress in several key areas:

- In 2023, Pony Club WA was host of the National Championships; an exciting event to celebrate all disciplines within Pony Club. To encourage increased participation of this great event, we trialled a hybrid competition format, offering a combination of in-person and virtual competitions running throughout hubs across Australia. While this new format presented some challenges for our staff and riders alike, it allowed for greater participation for all riders across Australia with record participation numbers. We will use feedback from this event to continue developing the Pony Club Nationals for future host states.
- In 2023 WA members gain international representation across the disciplines of Active Riding, Dressage and Showjumping.
- Following a significant financial loss to the association in 2022, we are pleased to have improved the financial stability of the association, as outlined in the 2023 financial report. The board and management have put measures in place to improve the financial security of Pony Club WA, with better visibility and a more collaborative approach across all committees.



Of course, we also faced some challenges along the way, including a change to our leadership team. Rick Gill stepped down as CEO after 3.5 years with Pony Club WA and we would like to thank him for his leadership and contribution and wish him the best as he moves on to other endeavours. I would also like to thank Tanya Appleby for stepping in as Acting CEO, taking on this role during a busy and challenging time for the association. I would like to recognise the incredible efforts of our staff, Tanya, Vanessa, Sally and Wanda, who worked tirelessly behind the scenes to ensure the success of our events and programs during this transition.

We are pleased to have Tanya Appleby appointed into the role of General Manager in early 2024 and we look forward to working with her to develop Pony Club WA events and initiatives.

Our success wouldn't be possible without the support of our wonderful volunteers, and I'd like to express my sincere thanks to our committees, coaches and officials who volunteer their time to run our events and programs throughout the year. You are the heart and soul of Pony Club WA, and your contributions make a significant difference in the Pony Club community.

The Pony Club WA board have also farewelled some long-standing members - our previous Chair, Karl Stokes, along with Casey Pearce and Dianne Colley during 2023. Ann-Marie Lowry, Vanessa Symons, and Amelia Thomas will also finish their term on the board at this Annual General Meeting. These board members have volunteered many years to Pony Club WA, and we would like to sincerely thank them for their contributions. Nadine Bennett and I were appointed to the board in August, and we are pleased to join the team of staff and volunteers that help develop grassroots equestrian, providing opportunities to our young riders to gain knowledge and become proficient in their chosen equestrian sport.

2023 PETSTOCK PCA NATIONAL CHAMPIONSHIPS

The Pony Club Australia Petstock National Championships were held from 1-5 October at the State Equestrian Centre in Brigadoon, Western Australia. The Pony Club Australia National Championships is held every 2 years. It includes competition in the Olympic disciplines of Dressage, Eventing, Showjumping and Tetrathlon (a modified version of Modern Pentathlon). Western Australia had not hosted the Nationals since 2013 and was eager to showcase our WA hospitality. The concept of a hybrid event allowed for a record number of entries and required additional planning and implementation. The hybrid style enabled us to host an inclusive event while ensuring a fair and equitable competition was conducted.

We would like to thank our major sponsors, the Department of Local Government, Sports and Cultural Industries, Petstock, City of Swan and Pony Club Australia for their generous support of the event. We would also like to acknowledge the many local businesses who supported the event through products, vouchers, and championship awards.

The disciplines held in WA were Eventing, Tetrathlon and Quiz. Interstate hubs hosted Showjumping, Dressage (videoed), Tetrathlon Jumping Phase and Quiz (conducted virtually) for competitors from Victoria, NSW, Queensland, South Australia and Northern Territory. The videos of the Dressage were uploaded for judging along with the scores attained from the Showjumping and Tetrathlon Jumping Phase held in each hub to gain points toward the coveted Roger Brahm OAM Perpetual Shield for the Champion State Team.

The Tetrathlon riding phase was completed at Home State hubs. This meant the horses did not need to make the journey across Australia. This was acknowledged as an important move for Horse Welfare to reduce the stress of travel and risk of injury. All Tetrathlon competitors came to Western Australia to compete in the unmounted phases. Swimming was held at Guildford Grammar School, shooting and running at the State Equestrian Centre here in Brigadoon. The National Eventing competition was held here in Western Australia with Cross Country at Wallangarra Pony Club and the Showjumping and Dressage phases held at the State Equestrian Centre. The Mounted Games competition was hosted by Western Australia at Benalla in Victoria.

Our Staff, Board, Volunteers and Officials went to great lengths to deliver a National Championship to a high standard ensuring governance and risk management requirements were implemented. The introduction of Masters Competitions (over 25 years) and Sub Junior riders (10 – 12 year) at this Championship added to the inclusivity and record entries for this competition.

We had a WA team of 93 competitors. Hosting the National Championships allowed WA members, who would not usually be able to attend the competition if it were held on the East Coast the opportunity to participate. Regional riders made up more than a third of our team. This was our largest WA team ever. We

had riders compete in every discipline – a record we are very proud of. In total approximately 500 horse and rider combinations competed in the Championships – a record number for the event. WA riders competed in every discipline offered – another record we are very proud of. We also had riders competing in WA from Queensland, Tasmania, South Australia, Victoria and New South Wales.

Competitors from Queensland spent several weeks in Western Australia after making the long trek across the country. They made the most of their time to tour around our regions. We had many family groups from the other States take the time to have a holiday in WA. This was a boost to our tourism and the businesses they supported during their trip.

Riders from the Northern Territory Hub competed at Fred's Pass Sport & Recreation Reserve. We did not have any competitors from the Northern Territory attend the Nationals event in WA. They were however extremely supportive of the Hybrid concept and also had record numbers competing.

The Tasmanian Hub was held at Grammar Equestrian Centre, Invermay. We had Tasmanian teams competing in WA for the Tetrathlon and Quiz competitions. Tasmania were very supportive of the Hybrid concept.

Victoria, New South Wales and Queensland shared a Super Hub in Victoria. Each State had riders competing in teams in WA for the Tetrathlon and Quiz competitions. Queensland also sent riders for Dressage, Showjumping and Eventing.

The South Australian Hub was held at Danson Dressage, Birdwood. As another more isolated State, South Australia has been very vocal in their support of the Hybrid model of the competition. They had riders competing in WA for Quiz and Tetrathlon. Full teams in all other disciplines made the competition a strong and competitive field.

As this was a Hybrid event, with judging of several competitions online after the event, much of the workload took place after the Nationals competition finished in WA on 5 October. Delays to uploading the videos to be Judged by several States prolonged the process further and caused additional delays. Postage of trophy rugs and prizes directly to riders was delayed by supply shortages in WA, train derailments and extreme weather conditions that impacted both rail and road transport, closing the transport link for a period of time. The Roger Braham OAM Perpetual Shield for the Champion State Team was awarded to Western Australia. The shield is proudly displayed in the Pony Club WA Office until the next Pony Club Australia National Championships in 2025.

High Performance Program

Pony Club WA with the support of The Races WA have continued to provide State High Performance Squads which assists with increasing skill, knowledge and experiences to riders achieving high levels of performance.

This continued initiative aims to increase participation in disciplines and encourages rider and mount combinations with the potential to compete in higher levels of sport and develops riders in preparation for Pony Club Australia National and International Events.

Pony Club WA currently offer the following State Squads leading support from our State Sport Committees:

- Active Riding
- Dressage
- Eventing
- Showjumping
- Tetrathlon

Each Discipline has a selection criterion which is met by each rider before attaining a position on their nominated squad.

An exclusive section of the Pony Club WA website was created to highlight State Squads and gain great engagement with members, this creates a readily available and easy avenue to access event dates, resources for member and lots of other information to assist members with their time on the squad.

2023 saw many members being selected to represent in each State Squad. Members developed further skills, gained wonderful friendships amongst each other, and challenged their ridden and theory knowledge along the way.

2023 also saw the continuation of Online Training Workshops to provide additional learning opportunities for our members.

Pony Club WA is excited to continue the initiative again for 2024 assisting with the High-Performance Pathway and educating riders with an aim to attend and compete at National and International Events .

These activities fall under the Race Around the State programs which are delivered to clubs. Clubs then earn RATS “kilometres” based on a range of activities that encourages healthy lifestyles and behaviours. This has grown in popularity through over the past few years which it to the success of increased online activities.

This proved to work well moving the Go for 2&5 Healthy Quiz to an online survey format, as well as introducing our new Go for 2&5 Virtual Canteen and Quiz Competition.

The Virtual Canteen provided members an opportunity to share how they wish to see their club canteen by submitting their DREAM CANTEEN. Members were encouraged to submit 5 green, 3 amber and 1 red food and beverage item/s.

Quiz Competition has been a huge success with members of all ages being able submit answers to the quiz, this was run monthly and gave the members 50 Kms each submission.

Healthy Kids Healthy Horses formed the basis of recipe workshops held by clubs providing hands on experience creating healthy meals. All clubs holding workshops were presented with workshop packs that included recipe books, aprons, and lunch containers.

The recipe competition was hugely popular, seeing some of our members winning recipes in the new recipe books that have been kindly printed by Healthway and available to all clubs as a resource.

The Go for 2& 5 Fuel to Go and Play Online Training encourages the Pony Club community to train in nine quick and easy learning modules which included videos, text content, activities, and summary quizzes to clarify the knowledge learnt in the process.

An exclusive section of the Pony Club WA website was created for all Go For 2&5 Activities including activity updates, recipes, race status and forms for submitting evidence of Key Message promotion.

The State Coaching Panel is responsible for the policy and direction of Coaching throughout the Association, subject to the approval of the Board. The Panel is also responsible for the assessment of Coaches, the issuing of proficiency certificates, organisation of Schools for potential Coaches, arranging for assessment and issuing of certificates to Coaches, the inspection of potential new Club's facilities, and all other matters that may be relevant to Coaching for members of the Association.

LEADERSHIP

The panel continues to use the knowledge and experience of its members to upskill and develop coaches, assessors and riders. Several proficiency assessors attained their C accreditation, and a couple progressed to C*/K level. These efforts ensured that we have a skilled group of assessors guiding rider development across Western Australia. A huge thank you goes out to the assessors who supported C & C*/K Assessments in 2023 for riders aiming towards Nationals Selection.

The SCP said farewell to Natasha Naylor, who joined the panel whilst still in her riding years of Pony Club. After 11 years she has taken the opportunity to focus on her family and own riding. We thank Natasha for her dedication to the membership during her time on the Panel.

HIGHLIGHTS

- The PCANCAS Level 1 Qualification saw significant progress and was published early 2024. The Panel was pleased to have been asked to contribute towards the content of the new manual and provide feedback on the draft. - The organisation and delivery of the PCA National Quiz was a highlight and learning experience for the panel.
- The SCP has formally welcomed 1 new panel member to the SCP with 2 more on probation as of Feb 2024 development across Western Australia. A huge thank you goes out to the assessors who supported C & C*/K Assessments in 2023 for riders aiming towards Nationals Selection.
- The SCP said farewell to Natasha Naylor, who joined the panel whilst still in her riding years of Pony Club. After 11 years she has taken the opportunity to focus on her family and own riding. We thank Natasha for her dedication to the membership during her time on the Panel.

PARTICIPATION AND DEVELOPMENT:

The National gear checking manual is becoming more familiar to our members and with the WA precis it is working well. Our WA-accredited gear checkers are gradually swapping over to the national accreditation. -Expressions of Interest (EOI) for coaches to start or upskill their PCANCAS coaching journey were high in 2023, with ongoing support provided by our State NCAS Coordinator. - Seven zones received approval for the Coach the Coaches funding, providing financial (\$300) support for coach development.

REWARD AND RECOGNITION

- In 2023 more than 380 riders obtained proficiency certificates, with two riders (Caitlin Pritchard & Felicity Ericsson) earning their B Proficiency Certificate, demonstrating their dedication and hard work. A total of 425 certificates were gained by our members.

State Sport Committee Reports

State Active Riding Committee

MISSION

As one of Pony Club’s most popular disciplines, Mounted Games provides members of all ages and ability with a fun, fast-paced activity that not only teaches riding skills in an exciting and teamwork-driven environment, it also an ability to work together with other riders and a willingness to help one another. Pony Club Members compete in teams of four or five riders and have several opportunities to compete both Nationally and Internationally.

Opportunities abound for those wishing to pursue Prince Philip Mounted Games during their Pony Club career! The core values members learn in Pony Club also prepare them for other positions in the equine industry.

Riders of any skill level and ability can compete in Mounted Games and novelties, with beginners usually competing at the Lead line Walk-Trot level before moving on into the Junior and Senior advanced ranks. The levels are divided based on the ages of the riders.

Mounted Games was originally the idea of His Royal Highness, the late Prince Philip, as a way to encourage enthusiasm, participation, and training in younger riders without the need of expensive ponies or gear. A natural draw to all levels of riding abilities, Games provide a fun sport that teaches the basic natural aids, physical coordination, self-confidence, and teamwork skills. It also encourages sportsmanship and the proper care of their mounts in all riders.

They require a high degree of athletic ability, good riding skills, hand-to-eye coordination, determination, perseverance, and a competitive spirit.

Riders develop remarkable skills in the areas of timing, sense of space, speed and direction, coordination, agility and horsemanship. They also laugh a lot, which is the only way to deal with mistakes when anyone makes one.

PARTICIPATION AND DEVELOPMENT

WA Active Riding Committee is committed to the vision:

To provide the opportunity for every rider in WA to have a positive experience with horses through providing opportunities:

- For education.
- To learn responsibility, sportsmanship, and good citizenship.
- For enjoyment and/or competitive success with their ponies/horses
- Build confidence in themselves.

HIGHLIGHTS.

The Active Riding committee ran quite a few competitions in the lead up of the State Championships in 2023 this included.

State Active Riding championships again held at Serpentine Pony Club grounds over 2 days.

October

At the time we were mad deciding to run a WA National Competition in a totally different state. But with all the hard work of the committee especially Angela Herzer who was the backbone to all of the coordination of this epic event. When we pulled it off this would have to be one of the most memorable events we have ever undertaken. We battled the Nullarbor and a few hiccups on the way with vehicles which were fixed by the WA Dads and our own travelling mechanic/coach Sean Corbin. After a couple of days of non-stop rain 100mls the day before our comp, the 2 day planned event had to be scaled back to a jam packed 1 day event resulting in having to drop a couple of races, and change game location into the large enclosed sand arena instead of the proposed grass Polo X arena which more resembled a lake at that stage.

To lift the Allan Hession Memorial Trophy once is a great achievement, but to have the WA Senior team lift it up twice in consecutive years is quite an accomplishment for the WA riders' ponies and families that made the 3350 km trip to Benalla in October 2023. The Junior team had a great day and were proudly the Reserve Champion team close behind the NSW team by only one point.

We also ran a Gala dinner at the Benalla Sport grounds that was a great night by all accounts including a disco after all the formalities and speeches.

REWARD AND RECOGNITION

Kiera Dowding 2023 WA International representative with Dan Foster elected to coach the Australian team in November 2023 at Londonderry Pony Club grounds NSW. This competition included riders from America, New Zealand, Canada, and Great Britain. With the Australian team coming a close second to Great Britain.

WA Active Riding Committee repaired both national trophies and had the Northam Men's shed build a custom trophy box to protect the trophy for many more years of Pony Club life.

OUR VISION FOR 2024

2024 is looking to not be as fast paced as what 2023 was due to Nationals being an invitational year although it is looking like Victoria may run a junior and Senior competition in Sept – October which will be exciting for the WA riders and families.

One thing we are striving to achieve in the next 12 months is to have more than the two level one Coaches for PPMG. We have a few people that have expressed a keen interest in gaining that skill, we will very closely help and encourage those people and anyone else that is interested in doing this certificate.

State Dressage Committee

MISSION

The Dressage Committee is responsible for supporting and developing young riders by encouraging and giving them opportunities to ride at their highest level. Our intention is to grow the number of young people involved in Dressage by creating development opportunities for young dressage riders, supporting Pony Clubs who host dressage events and providing an opportunity to ride at State Championships levels. We also aim to attract, train, and retain dressage officials.

LEADERSHIP

The committee has brought with its valuable knowledge and skills, which has culminated in a successful year for the sport. The committee has utilised rider feedback from previous state championships to further to encourage participation and rider development and inclusion by expanding composite teams and higher-level test.

HIGHLIGHTS

We would like to take this opportunity to formally thank all the sponsors of the VH Saddlery 2023 State Dressage Championships, without your support the event would not be possible. The Championships in its new format held over three days was a huge success with 680 tests completed over the weekend. Freestyle test are always a favourite class for all competitors and the effort and detail that goes into costume making is truly outstanding. Every parent should be commended for this.

Feedback from riders post the event indicated their support of and appreciation for the new format indicating an appreciation for the more relaxed atmosphere with the additional day and for relaxation of the rules allowing composite teams to be formed, enabling those riders riding at higher level or smaller clubs a greater opportunity to participate.

PARTICIPATION AND DEVELOPMENT

The State Dressage Squad held several development events throughout the year supported by industry leaders of Dressage in WA who coached, judged, and provided extensive theoretical and practical knowledge targeting athlete development of both the horse and rider. These days were extremely well supported by riders and parents, with feedback overwhelmingly recommending access to additional training opportunities in future squad programs.

Training was provided to volunteers of the state championship event for the scoring platform **Nominate** to ensure judges were supported by writers familiar with the electronic scoring system. This was a new scoring system implemented in 2023 and will be utilised again for the 2024 event, therefore further training opportunities are planned in the first half of 2024.

Dressage Judge training was undertaken in early 2024 in collaboration with Wendy Barker, EA Judge Educator, for volunteers and G level judges to grow the capacity of suitably qualified judges for grass roots Pony Clubs dressage events. The course consisted of three Zoom sessions covering theory, an open book rule test covering EA and PC specific rules, and finally practical evaluation which comprised shadow judging at Wallangarra RPC, a range of riders and horses. The riders included a 7 year old girl doing her first ever Prelim test and others who were seasoned competitors. These tests were videoed, allowing rural and remote candidates to complete this aspect remotely. This program resulted in 19 people who are now accredited to judge Prep and Prelim tests at PC events.

REWARD AND RECOGNITION

The committee would like to offer congratulations to all dressage riders who rode at the VH Saddlery State Dressage Championships in 2023 noting many amazing tests and the high standard of results, which were carried over by those dressage riders selected to represent WA at the Pony Club National event. It is clear that the standard of dressage within Pony Club WA is consistently high resulting in the fabulous National team and individual results.

In 2023 the Dressage Committee received recognition for the development of the sport via the Pony Club Annual Awards program for which we are truly humble.

The State Dressage Committee Medal award program initiated in 2023 saw a number of riders achieve gold, silver and bronze medals in recognition of their high level of achievement within the dressage discipline.

OUR VISION FOR 2024

The Dressage Committee is committed to the continued development of our riders, officials and success of dressage events. In 2024 the committee aims to provide:

- Electronic writing education program for volunteers
- Judge training for volunteers
- Support of Pony Club High Performance development program
- Continuation of the Dressage Performance Medal program
- Provision of access to alternative format – virtual dressage events to provide access to rural and remote riders.

State Eventing Committee

MISSION

The State Eventing committee is responsible for creating and implementing Eventing rules, supporting Clubs who hold One Day Events and assisting to create positive events to foster and encourage riders in Eventing. We work with the Host Club to run the State Eventing Championships. We also implement programs aimed at attracting, retaining, and training officials.

LEADERSHIP

The 2023 committee members were Tracey Hobbs, Monique Perkins, Jenni Brown, Shaun Lowry, Peter Cook, Roxie Sinclair, Renae Srdarev and Julie Cameron. The Technical Delegates worked tirelessly for the year, managing events all over the State. Thanks to Sharon Shanks, Deb Ware, Heather Wyllie, Jenny Brett, Peter Cook, Noel Mustchin and Peter Madagan.

HIGHLIGHTS

Our highlight for the year was hosting the Eventing phase for Pony Club Nationals in Western Australia. Unfortunately, not many riders from Interstate made the trek across the Nullabor. Huge congratulations to the riders that came from Queensland to complete. The dressage and show jumping phases were held at the State Equestrian Centre and the cross country phase was held at the Wallangarra Pony Club, including the new 105cm course.

Our State eventing championships, which were to be held at Kalgoorlie, unfortunately had to be cancelled due to low rider numbers. Thank you to the Kalgoorlie committee for the hard work they put in prior to the event. A hybrid event was held at the Capel ODE in November, with only riders who had entered the Kalgoorlie event taking part.

PARTICIPATION AND DEVELOPMENT

Our 203 Squad riders had the opportunity to attend 3 training days and a camp. Under the guidance of Chief Coach Shaun Dillon, the riders had instruction for Dressage, Show Jumping, Cross Country, Vet discussions, rider mental health and wellbeing talks. Thank you to all of the instructors who presented over the year.

We held Zoom meetings for the Event Organisers to discuss new rules, organising strategies and other issues for Clubs.

VISION FOR 2024

We will strengthen 2024 with an Event Organisers zoom meeting, and a Technical Delegate zoom meeting. The plan is to hold more meetings this year to keep everyone up to date with information. Our aim for the year is to increase our Technical Delegate and Cross Country course designer numbers. We will support and assist clubs to run efficient events for rider participation and development.

State Hickstead and Hunter Trials Committee

MISSION

To continue to develop Hickstead and Hunter Trial Inspectors through working in conjunction with other Sports Committees. To improve on the delivery and participation of a great State Hickstead through more clubs running these types of events and hopefully encourage on-site officials within these clubs.

LEADERSHIP

The committee is made up of members who were the original members of the Taskforce to set up the rules for the Hickstead and Hunter Trials, so they bring a wealth of knowledge of the evolution of the discipline to the table.

Dianne Ould has once again led as Chair to a successful 2023 with the support of Peter Cook, Jacqui Van Rensburg, Juanita Brewer, and Wanda Longley.

HIGHLIGHTS

The participation of our Course Designers and Inspectors in the joint workshop with EWA Eventing and Pony Club WA workshop at Murray Regional Equestrian Centre on the 6th & 7th May at the Murray CCN 2023. The presenters were Syliva Williams Roberts and Pollyanne Huntington.

We were also able to assist 5 clubs with our 2022 Sports Equipment Grant to assist clubs to upgrade their equipment and provide a safe environment for horses and riders.

This year also saw the first Hickstead held at Eastern Hills Pony Club, so we hope Tash Forward, and her team will once again add this event to their club calendar for 2024.

PARTICIPATION AND DEVELOPMENT

Due to the PCA National Championships held in Perth in 2023, the HHT committee felt that the number of riders attending the State Hickstead Championships in early November, would not have been the minimum number of riders. So, with a heavy heart, the event was cancelled.

REWARDS AND RECOGNITION

To increase the interest of parents and senior riders to nominate for the committee as an ongoing succession plan.

State Showjumping Committee

MISSION

The Showjumping Committee's mission is to educate, encourage and support riders in the discipline of Showjumping and selection for the State Showjumping Squad and Teams. We aim to continue providing training and resources to officials, Clubs, volunteers, associated members and engage those who have an interest to become course designers and judges.

LEADERSHIP

The 2023 Committee comprised of eight members each bringing a wealth of knowledge, experience and passion for the sport. Each year the Committee work tirelessly to bring together the annual state showjumping championships, Pony Club WA Invitational Team jumping at the Perth Royal Show and more recently hosting the Pony Club International Alliance Showjumping for the past two years. The Committee also worked on the National Taskforce Committee to host the 2023 PCA National Championships which were held in Perth.

We are truly fortunate to have Fred Freeman and Kevin Gianatti as advisors again this year, both integral to the success of the state championships. Program and sponsorship were once again successfully driven and implemented by Nadine Bennett with Wanda Longley and Rachael Mason coordinating and running the state Squad. Committee members Felicity Council, Stephen Johnson and Donnett Edwards were invaluable in all Committee endeavours.

HIGHLIGHTS

This year the Committee worked together with Simon Barry from Jumping WA to present workshops for reaccreditation of officials as well as those interested in becoming showjumping officials.

The first workshop was held at Moonyoonooka Horse and Pony Club with presenters Penny Dodd (Judging) and Fred Freeman (Course Design). In February Pony Club WA was invited to join Jumping WA at a workshop for Judges only. Later in the year Jumping WA and Pony Club WA held a joint workshop for Course Designers in Albany which was well received.

The workshops would not be able to run without the support of hosting clubs and our trainers Penny Dodd, Fred Freeman, and Kevin Tully.

WA again hosted the Pony Club International Virtual Showjumping competition. The event was held at Swan River grounds at Brookleigh with Fred Freeman as Course Designer and Rosemary Inglis judging. This year we had the inclusion of the Master Class (riders over 24 years). Once again WA was the only state to put forward teams to represent Australia against other competing countries including the United Kingdom, South Africa, and Hong Kong.

The Australian Team placed: Subjuniors: 2nd, Juniors: 3rd, Seniors: 5th and Masters: 2nd.

The 2023 State Championships were held at the SEC in May and proved once again to be the highlight for many riders which was conveyed through the rider's survey. The Program was designed to accommodate and challenge riders over the three days. We started the competition with the popular Welcome Stakes held indoors Friday afternoon. The Championships were officially opened with an acknowledgment to Country and awareness of the Dolly's Dream Foundation which was the beneficiary of funds raised over the duration of the competition.

Saturday night Bingo and mini quiz was once again held to a sell-out audience with the raffle, silent auction and gold coin donation all going towards Dolly's Dream.

PARTICIPATION AND DEVELOPMENT

Three clinics were held over the year for our State Squad members at Baldivis, Peel and Bunbury Pony Clubs. The clinics were also an avenue for new riders interested in becoming 2024 members.

As the Nationals were being held in October, it was felt we needed to provide our riders with a final clinic at Bunbury Pony Club which was a two-day clinic. Thank you to Rachael Mason for putting the clinic together with instruction from coaches Shaun Dillion, Tessa Lilli and presenter Darren Jenkins who is an accredited exercise Physiologist and Exercise Scientist.

Central Zone

MISSION:

The Central Zone aims to ensure the two clubs in the zone support each other's events.

Leadership:

Dryandra Pony Club is currently filling the roles of Central Zone President, Secretary, Treasurer and Chief Coach. This year has seen the Central Zone Constitution updated and a backlog of Annual Information Statements lodged. Central Zone has continued to contribute to the wider Pony Club WA community with Linda Page on the Dressage committee, Kristy Rae on the Showjumping Committee, Bill and Sarah Wiese on the Tetrathlon committee and Sarah Wiese on the Nationals Taskforce and National Tetrathlon Committee.

HIGHLIGHTS:

Dryandra ran a very successful Dressage and Show Jump series with three events in March, April and May and hosted an ODE in September with 120 competitors. The Narrogin Show finished the Dryandra events for the year. Wagin has hosted 2 major events the Funorama in March and the Gymkhanarama in September. The Gymkhanarama was a qualifying event for Eventing in the Park and was livestreamed lifting the profile of the event.

PARTICIPATION AND DEVELOPMENT:

Dryandra Pony Club had 31 riding members and 17 adult supporters and coaches, with a full rally and camp program with 7 rallies and 3 camps. Wagin has had 24 members this year, with adult riders being a significant proportion of the membership, and covered a variety of topics in their monthly rallies.

REWARD AND RECOGNITION:

Central Zone was represented at 4 State Championships this year. At Tetrathlon Champs Central Zone had riders in the winning 95cm Team and the winning 45cm Team. At Show Jump Champs Dryandra won the Brigid Woss Team event and Central Zone the Zone 1m Team event. At State Dressage Champs Central Zone had riders in the winning Zone team and the winning M'Liss Henry Pre-Caprilli Trophy and Dryandra came 2nd in the Plunkett Trophy. At the State Active Riding Champs 4 riders had a successful vaulting championships. Three riders from Central Zone also represented WA at the Pony Club Australia National Championships.

OUR VISION FOR 2024:

The goal of our rally program is to assist riders in working towards their certificates at all levels from E to B. We also aim to support and encourage more riders to attend State Championships and form Club and Zone teams.

Great Southern Zone

MISSION

The GSZ aims to continue to support the 6 regional clubs in our zone to provide a healthy and productive environment for all it's pony club members. The zone looks to provide support where small club numbers would normally prohibit the club from being able to provide that service/event. The zone looks to provide local events as the 5hrs travel one way to Perth and associated cost and time required to undertake this journey prohibits many of our riders and supporters from attending events in the metro area. The zone also looks to facilitate inter club events in the spirit of pony club. The zone looks to encourage all clubs to work together for the greater good of all pony clubs and their members.

LEADERSHIP

We have kept the same primary committee from 2023 to 2024 with President Michelle Ericsson (KRPC) Super Secretary Heather Knight (APC) Treasurer Michelle Ericsson (KRPC) Coaching Coordinator and primary driving force in the zone, Ferne Faulkner (WPPC) Reps 2 from each club APC, KRPC, DPC, WPPC, Koj PC and Ka PC.

HIGHLIGHTS

To conclude 2023 the GSZ run a very successful interclub quiz. We have teams from 4 of the 6 clubs and all enjoyed a very fun quiz compiled by Ferne Faulkner. The GS zone sent riders to PCWA State Tet, State SJ, State Dressage. We had 2 riders from the zone successfully achieve their B certificate. The first in many years.

PARTICIPATION AND DEVELOPMENT

The GSZ facilitated a virtual gear checking seminar for local participants. We hosted a C assessment today with 5 riders passing this assessment. The B assessment exam was completed in Albany at the King River Pony Club thanks to the support of PCWA and Philippa Collier. In the region there was a GSZ SJ run off and Dressage run off days to determine riders to be selected for the zone to compete at the State champs. Planning has commenced for coach the coaches seminar to continue to build on the capacity of our local coaches to be held in the GSZ. We will also look to have those who completed the onling gear checking seminars to complete their practical assessment and obtain their accreditation.

REWARD AND RECOGNITION

The GSZ hosted a very successful volunteer recognition lunch at the KRPC in Dec 2023. This was attended by 5 of the clubs in the zone. Each club nominates an U17 and 17yr+ club ambassador (the perfect pony club member) and club volunteer. These are recognised at the lunch with a few words highlighting their contribution. They receive a certificate and small gift as small token of appreciation of the amazing work they do.

CHALLENGES IN 2024

Each club in the zone has the normal ebbs and flows in membership numbers. Most clubs rely on the support of a few hard working volunteers who are the same volunteers on the GSZ committee. Filling zone committee positions each year is a very difficult task. The need for more and more "accredited" volunteers to run a club has made considerably more work and added more challenges for these small rural clubs to operate and run rallies and events. The GSZ in 2023 could no longer access the sizable Sport and Rec grant which allowed the zone to be quite active in it's support of it's clubs. The grant criteria had changed considerably and for the first time in many many years the GSZ did not receive any financial support from any agency in 2023. This year Sport and Rec have advised that it is likely the previous GSZ regional funding will be centralised to PCWA. The zone will await communication from PCWA as to what support we can then access via this funding.

VISION FOR 2024

The zone has highlighted the need for a locally run coach the coaches clinic and preparation has begun for this to be held in the zone in July 2024. Following on from successful C exams last year the zone are also planning for a locally run C* clinic to facilitate riders in our zone to go on and complete their C*. The zone is planning to continue to run the end of year inter club quiz and volunteer recognition awards. The zone would welcome direct communication from PCWA and consideration for PCWA run rural (within a 2hr drive of where we live) clinics, coaching opportunities and officials development to be provided in our zone.

South Eastern Zone

The South Eastern Zone is made up of three different Pony Clubs – Esperance Pony Club, Kalgoorlie District Pony Club and Munglinup Pony Club. Unfortunately, the Munglinup Pony Club is currently in recession which has resulted in several members now travelling a distance of 200km to attend a Rally at Esperance Pony Club. (400kms return trip).

With the tyranny of distance aside the Kalgoorlie District Pony Club and Esperance Pony Club still hosted several One Day Events, Rallies, Camps, Dressage and Show Jumping Series and a Coach the Coaches Clinic.

Covering a sizeable distance between the three clubs in our zone, the membership spread is as follows:

3 Junior Members 2 Senior Members 5 Adult Riding Members	34 Junior Members 3 Senior Members 9 Adult Riding Members

To date one rider from Kalgoorlie and 8 riders from Esperance have completed their Certificate Assessments graduating up to C Certificate levels. There are another 5 in Esperance set to complete their assessments in 2023.

Three coaches from Esperance Pony Club (Mareeka Coward, Melissa Spurling & Dorothy Henderson) started the year off by attending the State Coaching Clinic in Perth. This was one and a half days of interesting talks and demonstrations and a great opportunity to speak directly to the PCAWA Office Staff.

Through the year Kalgoorlie and Esperance Pony Clubs put on their eventing colours with Kalgoorlie Pony Club offering the Golden Nugget for its 26th year and the Esperance Pony Club holding two successful One Day Events. Financially these events are not very rewarding for the clubs once costs associated with flights and accommodation for Technical Delegates, Judges and Ambulance fees are taking into consideration. However, both clubs happily run them as they are a highlight for many riders within the clubs.

It was very disappointing to have the State Eventing Championships in Kalgoorlie cancelled due to lack of rider support. The Kalgoorlie District Pony Club had put a lot of time, money and volunteer hours into getting their grounds into great condition for this event and the cancellation just highlighted the Metro v's Country divide. Country riders undertake many trips to and from events, including State Competitions and PCWA Training Events held in metro areas, covering the costs of fuel and organising their own accommodation and travel arrangements. However, it seems, even with incentives such as discounted horse trucking costs and stop over camping options promoted, a number of riders / parents / supporters did not deem this State Event feasible. This was equally disappointing for those riders who made the effort of qualifying for this state event who now have missed out on an opportunity to represent their club in a State Championship in 2023. Another factor that locally divided our riders was State Eventing Championship being held on the same weekend as the Esperance & Districts Agricultural Show. This clash of events in itself was concerning to both Esperance Pony Club and Kalgoorlie District Pony Club riders from the outset as riders would have preferred to have supported both events (being in their 'local area') then choose just one.

Throughout the year the Esperance Pony Club held a very successful Show Jumping and Dressage Series due to considerable effort from Melissa Spurling and Desiree Sanderson. Together they offered four separate events with fantastic sponsorship and support through the series. Judges for the Dressage on all occasions were official thus giving our riders a chance to be judged by judges who

assess riders from around the state on a regular basis. This is very important as it helps keep our riders in touch with standards expected at all levels around the state. Unfortunately, unofficial judges cannot offer that same level of competition experience.

The Zone Pony Club Camp was held in Esperance and was well supported by riders from both clubs with coaching offered from Stephen Johnson, David Carey, Deb Spencer and Dan Foster. Dan was the highlight of the camp, coaching riders in all aspects of Active Riding. This success resulted in Dan returning to Esperance for the Agricultural Show to run a Games Competition. Again, the tyranny of distance nearly ran afoul of the camp with Regional Express Airlines cancelling the coaches' flights at the last minute. Luckily Mr Games became Mr Chauffeur and drove our coaches from Perth to Esperance which was a seven-hour journey some had never experienced before.

The October Training Camp held at Esperance Pony Club was also opened to Kalgoorlie District Pony Club Riders to attend as Katie Vuletic from "Horse Archery with Katie" ran a Coach the Coaches Clinic. This was generously supported by the State Coaching Panel and allowed our riders to have ridden lessons with Katie in all things Horse Archery with these followed by theory sessions at the end of the day with interested coaches. Throughout the ridden sessions interested coaches were rotated through lessons to gain an insight on how to coach archery to our riders in the future. Again, a big thank you to the State Coaching Committee for their supporting this. At this camp we were fortunate to have Natalie Hibbert, Katrin Kuentler and Philippa Collier join Katie in coaching our riders.

Esperance Pony Club had several riders qualify and enter State Championships in Dressage, Show Jumping and Eventing however, horse and rider illness saw a few riders miss out which was disappointing for them. Congratulations to Isabelle Cox who had a very busy year representing Esperance Pony Club at a Local, State and National level in 2023 in Tetrathlon, Show Jumping and Eventing and was selected to represent Australia in the upcoming PCAWA China tour. Her dedication to the sport, and the support from her family, is inspiring to many riders.

Rallies have been well attended through the year with Kalgoorlie offering eight rallies and Esperance Pony Club hosting ten rallies. On two occasions riders from Esperance have visited the Kalgoorlie District Pony Club to attend their Rallies to make the most of the visiting coaches that Kalgoorlie District Pony Club host. These coaches include David Carey and Natalie Hibbert whom are both respected coaches amongst their peers.

1 Statement of significant accounting policies

The Board have prepared the financial statements on the basis that the Association is a non-reporting entity because there are no users dependent on a general purpose financial report. The financial report is therefore a special purpose financial report that has been prepared in order to meet the requirements of the Association Incorporations Act 2015.

These financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and Interpretations and the disclosure requirements of AASB 101 Presentation of Financial Statements, AASB 107 Statement of Cash Flows, AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors, and AASB 1054 Australian Additional Disclosures.

1.1 Basis of preparation

The financial statements have been prepared on an accruals basis and are based on historical costs modified by the revaluation of selected non-current assets and financial instruments for which the fair value basis of accounting has been applied.

1.2 New and amended standards adopted by the Association

The Association has adopted all the amendments to Australian Accounting Standards issued by the Australian Accounting Standards Board, which are relevant to and effective for the Association's financial statements for the annual period beginning 1 January 2023.

None of the amendments have had an impact on the Association.

1.3 Significant accounting policies

Inventories

Inventories are measured at the lower of cost and net realisable value. The cost of manufactured products includes direct materials, direct labour and an appropriate portion of variable and fixed overheads. Overheads are applied on the basis of normal operating capacity. Costs are assigned on the basis of weighted average costs.

Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

Property, plant and equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment losses.

Plant and equipment are measured at cost less depreciation and impairment losses.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Association and the cost of the item can be measured reliably. All other repairs and maintenance are charged to the statement of profit or loss and other comprehensive income during the financial period in which they are incurred.

Depreciation

The depreciable amount of all fixed assets including building and capitalised leased assets, but excluding freehold land, is depreciated on a straight line basis over their useful lives to the Association commencing from the time the asset is held ready for use. Leased assets and leasehold improvements are depreciated over the shorter of either the unexpired period of the lease or the estimated useful lives of the assets.

The depreciation rates used for each class of depreciable assets are:

<i>Class of fixed asset</i>	<i>Depreciation rate</i>
Computer software & hardware:	40% - 100%
Plant and equipment:	10% - 100%

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each reporting period date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are included in the statement of profit or loss and other comprehensive income.

When revalued assets are sold, amounts included in the revaluation reserve relating to that asset are transferred to retained earnings.

Impairment of non-financial assets

At each reporting date, the Association reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

Any excess of the asset's carrying value over its recoverable amount is expensed to the statement of profit or loss and other comprehensive income.

Employee benefits

Short-term employee benefits

Short-term employee benefits are benefits, other than termination benefits, that are expected to be settled wholly within twelve (12) months after the end of the period in which the employees render the related service. Examples of such benefits include wages and salaries, non-monetary benefits and accumulating sick leave. Short-term employee benefits are measured at the undiscounted amounts expected to be paid when the liabilities are settled.

Employee benefits (continued)

Other long-term employee benefits

The Association's liabilities for annual leave and long service leave are included in other long-term benefits as they are not expected to be settled wholly within twelve (12) months after the end of the period in which the employees render the related service. They are measured at the present value of the expected future payments to be made to employees. The expected future payments incorporate anticipated future wage and salary levels, experience of employee departures and periods of service, and are discounted at rates determined by reference to market yields at the end of the reporting period on high quality corporate bonds that have maturity dates that approximate the timing of the estimated future cash outflows.

Any re-measurements arising from experience adjustments and changes in assumptions are recognised in profit or loss in the periods in which the changes occur.

The Association presents employee benefit obligations as current liabilities in the statement of financial position if the Association does not have an unconditional right to defer settlement for at least twelve (12) months after the reporting period, irrespective of when the actual settlement is expected to take place.

Provisions

Provisions are recognised when the Association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

Provisions are measured using the best estimate of amounts required to settle the obligation at the end of the reporting period.

Cash and cash equivalents

Cash comprises cash on hand and demand deposits. Cash equivalents are short-term, highly liquid investments that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

Revenue

Revenue arises mainly from fees received from members and revenue from sporting events.

To determine whether to recognise revenue, the Association follows a 5-step process:

- 1 Identifying the contract with a customer
- 2 Identifying the performance obligations
- 3 Determining the transaction price
- 4 Allocating the transaction price to the performance obligations
- 5 Recognising revenue when/as performance obligation(s) are satisfied.

The total transaction price for a contract is allocated amongst the various performance obligations based on their relative stand-alone selling prices. The transaction price for a contract excludes any amounts collected on behalf of third parties.

Revenue (continued)

Revenue is recognised either at a point in time or over time, when (or as) the Association satisfies performance obligations by transferring the promised goods or services to its members. The Association recognises contract liabilities for consideration received in respect of unsatisfied performance obligations and reports these amounts as other liabilities in the statement of financial position. Similarly, if the Association satisfies a performance obligation before it receives the consideration, the Association recognises either a contract asset or a receivable in its statement of financial position, depending on whether something other than the passage of time is required before the consideration is due.

Interest revenue is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount.

All revenue is stated net of the amount of Goods and Services Tax (GST).

Leases

The Entity considers whether a contract is, or contains a lease. A lease is defined as 'a contract, or part of a contract, that conveys the right to use an asset (the underlying asset) for a period of time in exchange for consideration'.

To apply this definition the Entity assesses whether the contract meets three key evaluations which are whether:

- the contract contains an identified asset, which is either explicitly identified in the contract or implicitly specified by being identified at the time the asset is made available to the Entity
- the Entity has the right to obtain substantially all of the economic benefits from use of the identified asset throughout the period of use, considering its rights within the defined scope of the contract
- the Entity has the right to direct the use of the identified asset throughout the period of use. The Entity assess whether it has the right to direct 'how and for what purpose' the asset is used throughout the period of use.

Measurement and recognition of leases as a lessee

At lease commencement date, the Entity recognises a right-of-use asset and a lease liability on the balance sheet. The right-of-use asset is measured at cost, which is made up of the initial measurement of the lease liability, any initial direct costs incurred by the Entity, an estimate of any costs to dismantle and remove the asset at the end of the lease, and any lease payments made in advance of the lease commencement date (net of any incentives received).

The Entity depreciates the right-of-use assets on a straight-line basis from the lease commencement date to the earlier of the end of the useful life of the right-of-use asset or the end of the lease term. The Entity also assesses the right-of-use asset for impairment when such indicators exist.

Measurement and recognition of leases as a lessee (continued)

At the commencement date, the Entity measures the lease liability at the present value of the lease payments unpaid at that date, discounted using the interest rate implicit in the lease if that rate is readily available or the Entity's incremental borrowing rate.

Lease payments included in the measurement of the lease liability are made up of fixed payments (including in substance fixed), variable payments based on an index or rate, amounts expected to be payable under a residual value guarantee and payments arising from options reasonably certain to be exercised.

Subsequent to initial measurement, the liability will be reduced for payments made and increased for interest. It is remeasured to reflect any reassessment or modification, or if there are changes in in-substance fixed payments. When the lease liability is remeasured, the corresponding adjustment is reflected in the right-of-use asset or profit and loss if the right-of-use asset is already reduced to zero.

The Entity has elected to account for short-term leases and leases of low-value assets using the practical expedients. Instead of recognising a right-of-use asset and lease liability, the payments in relation to these are recognised as an expense in profit or loss on a straight-line basis over the lease term.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

Cash flows are presented in the statement of cash flows on a gross basis, except for the GST component of investing and financing activities, which are disclosed as operating cash flows.

Significant management judgement in applying accounting policies

The following are significant management judgements in applying the accounting policies of the Association that have the most significant effect on the financial statements.

Estimation uncertainty

When preparing the financial statements management undertakes a number of judgements, estimates and assumptions about recognition and measurement of assets, liabilities, income and expenses.

The actual results may differ from the judgements, estimates and assumptions made by management, and will seldom equal the estimated results.

Information about significant judgements, estimates and assumptions that have the most significant effect on recognition and measurement of assets, liabilities, income and expenses is provided below.

Useful lives of depreciable assets

Management reviews the useful lives of depreciable assets at each reporting date, based on the expected utility of the assets to the Association. Actual results, however, may vary due to technical obsolescence, particularly relating to software and IT equipment.

Inventories

Inventories are measured at the lower of cost and net realisable value. In estimating net realisable values, management takes into account the most reliable evidence available at the times the estimates are made.

Provisions – Long service leave

The liability for long service leave is recognised and measured at the present value of the estimated future cash flows to be made in respect of all employees at the reporting date. In determining the present value of the liability, attrition rates and pay increases through promotion and inflation have been taken into account.






