AWARDS

HIGH POINTS

There will be a High Point Champion rug awarded to each of the following heights: 60cm, 70cm, 80cm, 90cm, 100cm & 110cm. These will be presented at the Annual Awards Evening. Points will be accumulated over Saturday and Sunday competitions highlighted in blue on the program.

SHOWJUMPING TEAM EVENT PERPETUAL TROPHY

This trophy is given to the team placing first in the Showjumping Team Club Challenge. The trophy was kindly donated by Swan Zone.

Team Rugs will be awarded to winners of Club Team and Zone Team.

OFF THE TRACK

All thoroughbreds and standardbreds bred for racing that compete at the Championships qualify for the Off the Track Award. When entering, you will be asked to include your Off the Track passport number and the racing name of your horse. Awarded to eligible horses that compete in Individual and Team classes on Saturday and Sunday. The presentation will take place on Sunday afternoon.

STATE SHOWJUMPING CHAMPIONSHIP INFORMATION

QUALIFICATION CRITERIA

Horse/rider combinations must meet the below qualification criteria in the 12 months preceding 28 April 2025

Rally Qualification criteria:

- 1.1 attend a minimum of three hours at three separate Working Rallies within the 12-month period required by the event or competition, two of which must be at the club at which they are a member;
- 1.2 participate in at least one ridden session at each Working Rally;
- 1.3 if riding two horses at a Working Rally, participate in at least one ridden session on each horse; and
- 1.4 if a riding member has achieved their C*/K Proficiency Certificate then a two rally qualification will apply.
- A maximum of two horses/ponies may be ridden by one rider at any Working Rally

Event Qualification criteria:

Each horse and rider must keep a Showjumping Performance Record, signed by an accredited Pony Club or EWA Showjumping Judge or Course Designer. This record should demonstrate that they have completed at least two rounds at the competing height or higher, with no more than 16 penalties, at an official event (Pony Club or EWA). The rider is responsible for maintaining this information and providing it to the Club as proof of their qualification. No training rounds, Eventing or Tetrathlon competition rounds will be permitted to be used unless applying for an exemption.

If applying for an Event Qualification exemption please use this <u>JotForm</u>. The club can quote rounds from Eventing, Hunter Trials, Hickstead, Tetrathlon and/or Combined Training. This exemption must come from a club official (Chief Coach, President or Secretary).

Neither the Organising Committee of the event to which these rules apply, nor Pony Club WA accepts any liability for any accident, damage, injury, or illness to horses, riders, spectators or any other person or property whatsoever.

The organiser reserves the right:

- To cancel any class or event
- To divide or combine any class.
- To transfer competitors between classes or sections of a class
- To alter the advertised times
- To refuse any entry, with or without stating the reason
- To amend placings dependant on class numbers

STABLES AND CAMPING

- All Stables and Camping should be booked online through the <u>Equestrian WA</u> website.
- Generators at campsites must be RCD protected and extension leads must be safety tagged.
- All waste in stables and yards must be removed before leaving the event.
- The State Equestrian Centre encourages people to secure their personal belongings.
- Yards are available free of charge at Swan Valley Fields.
- Horses not booked in stables are not to be tied up in the stable area.
- Please dispose of appropriate cans and plastic bottles in the Containers for Change bins

HORSES

The one horse, one rider rule will apply for all classes.

A rider may enter a maximum of 2 horses/ponies per day in the Championships.

RIDERS

Riders must be a current financial Junior or Senior Riding Members with Pony Club WA.

Rider age is calculated as the age on 01 January 2025.

If a rider scratches from the event after the close of entries, they are still responsible for their helper duty or to co-ordinate with their club to cover the rostered duty.

Rider Profiles are mandatory and should be 25 words or less.

TIMETABLE CLASHES

In the event of a clash, riders should prioritise team events. They must inform the arena marshals if they have a clash. A class cannot be held open for extended periods waiting for individuals to present. There will be no refunds if classes are missed.

WORKING WITH CHILDREN CHECK

A **WWC Check** is required by a person if they engage in certain paid or unpaid work with children, described as 'child-related work' under the WWC Act.

Volunteers engaged in helper duties at Pony Club WA State Championships where the **usual duties** involve, or are they are likely to involve <u>contact</u> with a <u>child</u> such as Team Manager, Gear Checking, and Marshalling, will be required to have a current WWCC unless a Parent Exemption applies. A Parent Exemption applies if you are volunteering and have a child under the age of 18 actively involved in the event you are volunteering at.

HELPER DUTIES

It is the responsibility of all riders to supply a helper per horse/rider combination (e.g. If you have two horses entered you must do two helper duties or if a family has multiple riders, helpers must be provided for each horse/rider combination.

The Helper Duties will be via Sign Up. Team Managers are expected to do a helper duty.

If a rider scratches after the close of entries, they are still responsible for providing a helper on the day or coordinating with your club to cover the rostered duty.

If you are using a paid helper and they are not a member of a Pony Club, please supply their name, and contact number on sign up, and a copy of their Working with Children must be emailed to membership@ponyclubwa.asn.au.

REFUND POLICY

Members requesting a refund should provide supporting evidence via the JotForm. Refunds must be requested within 7 days of the event and may be subject to a \$20 administration fee.

PONY CLUB WA - NO DOG POLICY

- This is a Pony Club WA event, and the policy of NO DOGS will be strictly adhered to. Failure to abide by this policy may result in the elimination of rider(s).
- Assistance animals approved by the Department of Local Government; Sport & Cultural Industries
 are exempt from this rule. Persons with an Assistance Animal may be requested to provide their
 approval documentation.
- If you have family members or friends attending, please remind them of the No Dog Policy.

ELECTRIC BIKES & E SCOOTERS

• Electric Bikes and E Scooters are not permitted in the stables, competition arenas and the President's Lawn.

HOW TO ENTER

Changes will not be made after this date unless a Medical or Veterinary Certificate is provided.

RIDERS

- Please set-up a rider profile and ensure your horse is registered on Just Go
- Apart from Combined Training, consecutive heights are permitted. All entries are subject to endorsement by the Club Declaration after confirming the Showjumping Performance Record.
- Entries will open at 7pm on Monday 14 April and close at 11pm on Monday 28 April 2025.

CLUB & ZONE TEAM EVENTS

- Clubs and Zones are requested to download and complete the Entry spreadsheet on the website
- Please upload the spreadsheet to JotForm duly signed and completed by 9am on Tuesday 29
 April 2025. No late entries will be accepted.
- Riders will have until 11pm on Monday 28 April 2025 to enter their Team & Individual classes.
- Only riders who have been notified by their Club or Zone of their selection to be on the teams can enter these classes.
- Clubs will be sent a declaration with riders' chosen classes to sign off on competency and rally qualification. A reminder to clubs that Rally Qualification is for twelve months from the close of entries.

FANCY DRESS - OPTIONAL

- All combinations must complete a Gear Check and comply to the PCA National Gear Rules.
- Rider outfit must include approved helmet and boots. Shoulders must be covered.
- Rider costume must be securely attached to the rider but not the horse; it must allow the rider to fall freely from the horse if needed.
- Horse costume must include a bridle and bit and be securely attached to the horse and/or saddlery. It should allow the rider to fall freely from horse if needed. The costume must have careful use of fastenings (e.g. Velcro, pins, elastic, string) and must not cause discomfort or restrict the horse's movement.
- Bell boots or exercise boots may not have decorations attached to them,
- Nothing in the fancy dress may present a tripping or tangling risk for the horse.
- Artificial colouring/spray painting of horses with non-toxic ingredients is permitted.

SUPPLEMENTARY INFORMATION

Please note: The only exception to the EA National Jumping Rules and FEI Rules for Showjumping are the Pony Club WA Showjumping speeds, as set out in the table below:

| HEIGHT | SPEED (metres per minute) |
|--------------------------|---------------------------|
| 105cm and above | 350mpm |
| 85cm to 105cm | 325mpm |
| Up to and including 80cm | 300mpm |

HORSES

Plaiting is not mandatory but is expected for the Combined Training, Club Team & Zone. Each horse or pony may only be ridden by one rider for the duration of the Championships. A competitor may enter and ride two horses over the Championship weekend excluding the Team Events.

RIDERS

Remember you are allowed to only do 3 jumping starts per day. Zone Teams classes count as 2 starts.

Consecutive heights are permitted, but only with the support of Show Jumping Performance Record and club declarations. **NOTE**: Combinations can only compete in one round in each class.

PRESENTATIONS

Presentations will take place at the conclusion of each class. Rosettes not collected can be picked up at the Event Office.

GEAR CHECKING

All saddlery must comply with the current Pony Club Australia Gear Rules and the Pony Club WA Gear Checking Manual Pony Club WA Appendixes to support the Pony Club Australia National Gear Rules.

Riders under the age of 18 years must present to the Gear Checker with a Parent or Guardian. Riders must be accompanied by the Team Manager for Gear Checking prior to the start of the Teams and Zone competitions.

If a rider has a Gear Exemption, it must be presented to the Gear Checker at each class entered.

CANCELLATIONS, SCRATCHINGS OR ALTERATIONS

If for any reason you wish to withdraw from a class during the event, please inform the Event office as soon as possible.

No entries on the day or swapping of classes will be permitted.

If you are withdrawing from a team, a form must be obtained from the event office and completed by the Team Manager. If your team has a duly qualified substitute, substitution forms will be available in the event office and must be completed by the Team Manager at least 30 minutes before the rider is scheduled to commence the class.


SWABBING
